- End User pricing can NOT exceed the DIR Contract Price but can be discounted by the Dealer.
- Dealer must identify all DIR quotes and orders to TD SYNNEX. Quotes can be obtained from your commercial sales team at TD SYNNEX and should be copied to TXDIR@TDSYNNEX.com.
- Both the End User and Dealer POs should reference DIR-CPO-5077. Dealer is responsible for maintaining a copy of these POs for audit purposes for up to 3 years following the date of that sale.
- Reseller must have a current account in good standing at TD SYNNEX and signed Dealer Agreement. To participate, please send request to Contracts@TDSYNNEX.com.
- TD SYNNEX and manufacturers' standard commercial certifications/authorizations are required for participation.

POS Reporting
